ACSS Secretariat Update (January 2022) Paper 8.1

1. Recruitment

As discussed with individual members, we are seeking to extend terms of appointment to September 2025. We will launch an ACSS recruitment campaign in March to fill posts where members haven't extended, and strengthen expertise in topics identified in the emerging FSA strategy. We are working to the following timeline for this.

Campaign launches: 12th March 2022Closing date for advert: 24th April 2022

Sift meeting: 9th-11th May 2022Interviews: 19th-27th May 2022

Induction to the ACSS: TBCIn post: September 2022

2. ACSS Ad hoc requests

Action 7.6 from the June 21 ACSS plenary, tasked the secretariat with exploring the ad hoc requests received by the committee, by mapping them on to FSA policy areas. The majority of the ACSS ad hoc requests come from the social science team, informing research relevant to one of more of the FSA areas of research interest (ARIs). In 2021, the ACSS received 10 ad hoc requests. As per figure 1, most (8/10) of these were relevant to the **Innovation in Regulation** theme, specifically the ARIs relating to behaviour ('What role does consumer and Food Business Operator behaviour and perception play in ensuring food safety and standards?') and consumer interests ('What is the consumer interest in the food system, including on safety and standards, nutrition and health, choice, availability, access, sustainability and welfare?'). The **Future of Food Systems** theme was also well covered by ad hoc requests (4/10), particularly the emerging

challenges ARI ('How can the FSA remain responsive to emerging challenges and opportunities in the UK food system including unprecedented challenges such as those associated with Covid-19?').

Topics relating to the **Assuring Food Safety and Standards** theme (e.g. the impact of food borne pathogens, chemical contaminants) were less well covered (1/10) reflecting the different evidence needs for these ARIs. Only 2 requests related to the **Food hypersensitivity and allergy** theme, which is likely due to the narrow focus of this theme (containing just one ARI).

3. Equity and inequalities in the work of the analytics unit

Action 7.2 from the June 21 ACSS plenary, tasked the secretariat with adding an agenda item to discuss *equity and inequalities in the work of the analytics unit*. The FSA are currently undertaking a review of the factors included in our impact assessments, to ensure data on equity, inequalities and other factors, are appropriately considered. Given the relevance of this planned work, the secretariat will facilitate this discussion at a later date when the review of impact assessments is complete.

4. SAC triennial review

The FSA are preparing to commission a Review of its Scientific Advisory Committees. The FSA's SACs are non-statutory and advisory non-departmental public bodies (ANDPBs) or Departmental Expert Committees (DECs) which are subject to triennial review under the Cabinet Office Public Bodies review programme. The last <u>triennial review of FSA SACs</u> was commissioned in September 2015 and concluded in 2016.

The purpose of this Review is to provide assurance to the FSA that the SACs roles and purposes are appropriate in addressing the future needs of the FSA, consumers and wider Government, and that the bodies are operating effectively against their objectives and provide recommendations for future ways of working.

The Review of SACs is led by an independent review and supported by a review team.

The FSA is currently waiting for the launch of the Cabinet Office's revised guidance to the Review of Public Bodies (which Reviews of SACs are covered); this is expected to be released at the end of January / early Feb. Soon after this FSA will decide the scope of its Review of the SACs. The secretariat will update members when more details are available.

2. Advisory Committee on Novel Foods and Processes (ACNFP)
